### No Co-existence

*But somewhere behind these moral neutralists [run-of-the-mill Communist theoreticians] there seems to be some demonic group or power, self-perpetuating throughout generations, which goes even further. It actively seeks to make hatred, instead of love, the great motivating force, and the ideal to be sustained to the limit of one's dedication, in the affairs of man.*

From the very beginning of his work on the elucidation of political economy, C. H. Douglas realised that finance was a political rather than an economic system; that is to say, that control of finance was the vehicle of a policy. The policy was centralisation of power, the pyramidal organisation of society, with those ultimately in control of finance the apex of the pyramid. It seemed to Douglas in his early investigations that such a modification of the financial system might be brought about, through an exposure of its mechanism and effects, as would render it ineffective as a vehicle of policy, so that it could serve purely economic ends, and thereafter the structure of society would be determined by natural organic relationships as modified by the increasing mastery of man over his environment, and the profound effects of inventiveness and power production. Nevertheless, his first major work, *Economic Democracy*, contained something more than a hint that such a rectification might be resisted by those whom the financial system, or the control of it, placed at the apex of power.

The early efforts of Douglas and of those numerous supporters he soon gained lay in expounding his views on political economy, soon known generally as Social Credit, throughout the world, in the hope that public opinion, working through existing institutions of democratic government, might force the necessary rectification. In only one area of the world—Alberta, Canada—did this effort show any real slight promise of success. A nominal Social Credit government was elected there. All it achieved, however, was the demonstration of what Douglas described as a fundamental factor in the world situation: that there were forces superior to the Albertan government which, operating through the Canadian Federal government, were determined to keep the world in turmoil until the rule of a presently Secret Government is supreme. Every Albertan attempt to implement Social Credit modifications of the financial system was disallowed by the Federal government.

But by this time the inability of the orthodox financial system to continue unmodified was obvious: government through finance had to be reinforced or replaced by police-state methods. It became clear to Douglas and some of his followers that a frontal attack on the financial system could never succeed, and that an exposure of and attack on the conspiracy behind it were the only hope of achieving a better world.

Douglas perceived quite clearly that the Second World War was contrived by, and to further the aims of, the Cons-

piracy, and all his efforts were directed to turning the war against the conspirators. He saw that the paramount necessity was less the defeat of Germany than the winning of the peace. But by the time the war ended it was quite obvious that this objective also was lost. Governments everywhere emerged as far more centralised and powerful, and financial power and governmental power were more and more merged. And it was clear also that the objective of achieving a visible, all-powerful international government was being pursued relentlessly.

What was not so clear, however, was the precise strategy by which this was to be achieved. America emerged from the war in an absolutely unchallengeable position, and certainly could have made, and kept, "the world safe for democracy". But it soon became clear to trained observers that this would be the last objective of U.S. policy. What in fact happened was that by massive disarmament, and in pursuance of secret agreements made during the war, the U.S. cleared the way for the Communist conquest of Eastern Europe and of China. By the support of "anti-colonialism", beginning during the war with tremendous pressure on Britain to abandon India, the U.S. cleared the way for the 'emergence' of 'newly independent' 'nations', in almost every case economically non-viable, and therefore dependent on 'foreign aid' which in almost every instance has simply financed the open or covert control by Communism in those countries. Most aid goes to those countries nearest to Communist power.

These developments have made it perfectly clear that *the International Financial Conspiracy and the International Communist Conspiracy are one and the same thing*; that the government of the world, which for centuries had been maintained through financial manipulation when the real nature of money and international finance were a mystery except to its manipulators, had to be transformed into police-state rule. Once the essential unity of these apparently *two* conspiracies is seen, the rise, development, extension and purpose of Communism are perfectly easy to follow.

"The *practical* history of Bolshevism may be said to commence with the *financing* of Japan in the 1904-1905 War against Russia. . . ." [our emphasis]

"At the same time: "The subsidies granted to the Nihilists at this period by Jacob Schiff were no longer acts of isolated generosity. A veritable Russian Terrorist organisation had been set up in the U.S.A. at his expense. It covered Russia with its emissaries, charged to assassinate Ministers, governors, heads of police, etc. . . . and to create insurrection . . . the cost was estimated at more than fourteen million (gold) roubles' (*Figaro*, Paris, February 20, 1932)": C. H. Douglas, *Programme For the Third World War*.

After this, Lenin elaborated the tactics of world 'revolution' which have remained the blue print of Communist conquest to this day. In 1917, Lenin and a gang of trained crimin-

als, mostly from New York were shipped into Russia, and, financed by Kuhn Loeb & Co., established a terroristic dictatorship over the Russian people, and in a few years extended control over the peoples of adjacent territories until they consolidated their grip over what was known as the Union of Soviet Socialist Republics. After this the task was to consolidate their gains to provide a territorial base for the next stages of world conquest. In this period, institutes were set up for the intensive training of professional revolutionaries and secret agents—a training lasting often for years—and these were infiltrated all over the world. But the actual physical expansion of Communist conquest required the Second World War, which was duly contrived after a deliberate Great Depression, brought about by the financial arm of the Conspiracy, had prepared the stage—and Hitler, who was financed through the Bank 'of England'—for it.

The long-range strategy laid down by, or through, Lenin, was "First, take Eastern Europe. Next, the masses of Asia. Then encircle that last bastion of capitalism, the United States of America. We shall not have to attack; it will fall like overripe fruit into our hands".

"Now there are many remarkable things about that three-step strategy. But the most remarkable is that the Communists have never wavered from it one iota in the thirty-five years since it was promulgated. Through famines which they deliberately caused in order to collectivise agriculture, through whatever industrialisation they have achieved, through wars which they have cleverly and cold-bloodedly brought on for the help of such wars in their plans, through periods of peace and prosperity elsewhere in the world, through power struggles in the Kremlin itself, through apparent changes and reversals in the party line that make non-Communist heads swim in confusion, through every upheaval and opportunity, the Communists have always kept their eyes unwaveringly on this strategy and on plans to carry it out.

"They have let nothing stand in their way, and nothing divert them. They have used the philosophy of socialism as an ideological weapon, in this struggle, whenever they could and for whatever it was worth. They have also used bribery, lies, bluff, brutality, the countless tentacles of treason, murder on a scale never before dreamed of in the world, and every possible means to advance them on this road, without the slightest concern for any moral difference in those various means. *A patient gradualism has been the most important key to the Communists' overwhelming success.*" (Robert Welch, *The Blue Book of the John Birch Society*.)

By 1950, the Conspiracy had Eastern Europe entire, and China. By 1954 they had most of Indo-China. By this time "the whole conspiratorial apparatus was rapidly marching forwards towards ultimate total victory. So rapidly, in fact, and so visibly, that a different kind of problem now loomed ever larger before them. That was the problem of keeping the remaining free world—and especially the American people—from becoming aware of how fast and how surely the Communists were taking over the rest of the planet.

"For this, and other highly advantageous reasons, the new régime in the Kremlin [and the old one in the U.S.A.] called a halt to the establishment of formal satellites, and began to extend its power through so-called 'neutralist' countries. . ." (Welch, *Op. cit.*)

This with the ominous exception of the establishment of a formal satellite in Cuba, is the background to the turmoil, bloodshed and chaos in Africa, the remnants of South-East

Asia, and everywhere else.

It is essential to realise that Communism is not to be identified with the formal Communist Party. Communism is an international conspiracy, staffed in its upper echelons by the richest men in the world, and other power-seekers who are attracted to some of its secret councils, and highly placed secret agents placed and kept in position by self-deception, lust for power, blackmail, corruption, terror, murder, and most of the crimes known to man. The Communist Party is one of the organs of the Conspiracy, controlled in secret from the top, and used as an agency for recruiting thugs and criminals, and for spreading corruption, subversion, and terror.

Douglas expressed the opinion that possibly the apex of this Conspiracy transcended normal human activity, so utterly evil, so demonic in conception it is. He also points out "the Great Seal of the United States, which was the work of Jefferson, John Adams, and Benjamin Franklin, the obverse of which consists of a truncated pyramid, with the headstone bearing a picture of the *All-Seeing Eye*, the symbol of Freemasonry, suspended above the pyramid. The motto is '*annuit coeptis*'—'he prospers our origins.'

"The pyramid is the symbol of world government. The rest of the symbolism is obvious. Seen in the light of this clue, the history of the United States is consistently bound up with Whiggism, Lutherism, Calvinism, and with the 'mergers', financial buccaneering and political corruption of the super-capitalism. . ." [as opposed to private enterprise]. (*Programme For the Third World War*.)

Communism is, always and everywhere, brutal police-state government imposed from the top, by corruption, subversion, centralisation, monopoly, and racial, religious, and industrial strife. Once this essential fact is grasped, it is simple to perceive the role of the Communist Party. That is to create the conditions of disturbance which appear to justify more central government power, and, eventually, police-state methods of quelling 'disturbance'. But then—resistance to police-state methods becomes 'rebellions', and 'illegal'.

This highly synoptic account of the essential history of this increasingly troubled century is not documented for three reasons, the last of which will appear later. Firstly, the fact that the century so far as it has gone, and with every indication of worse to come, has been increasingly troubled, can be attributed to one only of two possible reasons: either the ineptitude of those in control of fundamental political and economic decisions, or to conspiratorial control of those decisions. Well, all human beings are fallible, but the laws of chance are simply against such a consistent movement towards the same predictable disaster for us, as has overtaken one country after another—particularly in the context of the amazingly rapid progress of the industrial and agricultural arts.

Secondly, the operation of the conspiracy is now quite visible to anyone who can get his eyes off the TV and public press (both, of course, in the control of the Conspiracy) long enough to look at the map. If the nonsense about 'neutralism' is dismissed, it is easy to see that Europe is entirely outflanked; and in any case, Europe is so subverted that . . . as has been well put, the Conspiracy could take it over "by telephone" if it were considered expedient at this stage to do so. The northern part of Africa—the Mediterranean coast—is entirely Communist-controlled; and as Mao Tse Tung said after his recent visit, the revolutionary situation in the rest of the continent is "ripe". The defence line of Australia is shattered, and Britain, of course, is included in the European situation.

A careful recent estimate, by ~~recent~~ trained observers, is that the International Communist Conspiracy has achieved three-quarters of its goal of total global conquest, and that out of 130 countries listed, one hundred have more than 50% Communist control.

In considering these figures it must be realised that Communism is a system *imposed from the top*, and that such control can be, and is, maintained by no more than 3% of the population. Further, it is quite obvious that the nearer the Conspiracy approaches to total success, the more the real position must be concealed and confused. Any serious student who follows the public press and radio news and commentaries will soon be aware of the 'scrambled' presentation, and the 'party line' in commentaries. We recently tape-recorded two broadcast commentaries daily for a week, and then played them back. All the commentators were different, but the 'line', the interpretation, was clearly discernible as emanating from a common source.

All the above, if understood and appreciated by our readers, should make it apparent that nobody is going to have any slightest opportunity of tampering with the financial system. Is there anything else that can be done?

Highly competent students of the Conspiracy now consider that the U.S. government is now totally—100%—controlled by the Conspiracy. In considering that figure, remember that control can be maintained by a mere 3% of the population, *in the strategic position*. Remember, again, that control is pyramidal: that below the 3% are agents, some willing, others forced to conform by blackmail, corruption, and even terror. Remember that the strategy is to extend that pyramidal control ever downwards, through ever more unconscious agents, until the total apparatus of a police-state can be instituted under cover of an 'emergency'. Remember that the programme includes the immediate picking-up, and murder or imprisonment of potential leaders of resistance, and continuous mopping up thereafter until there is no further possibility of resistance. Remember that this exact programme has been carried out in three-quarters of the world, and that the well-to-do Cubans only a few years ago, did not believe it could happen to them. Remember that Executive Orders have recently been issued in the U.S. for use 'in an emergency' (unspecified) providing for the Federal seizure of communications, transport and property, for redistribution of population, and other comprehensive powers. What would be the use of such Orders if there were not ready the necessary organisation to carry them out? Against that background, consider the continued unemployment, the incitement to discontent by the "War on Poverty" (in a country which can't dispose of its production even by giving it away); the racial tensions fomented from below and incited from above by the Civil Rights programme\*, itself a Federal attack on property rights.

So what is to be done?

It was almost certainly the intention of the Conspiracy to extend their secret government so insidiously, and under cover of the ceaseless brainwashing being carried out through the mass media which also it controls, that the American people

\* Two past presidents of the American Bar Association describe the Civil Rights Act 1963 as follows: "[It] is skilfully drawn with the patent, deliberate intent to destroy all effective constitutional limitation upon the extension of Federal governmental power over individuals and the States. . . . Never in the history of nations governed by elected officials has the head of any state demanded the naked untrammelled power embodied in this Act, even when such state was on the verge of becoming a dictatorship. . . ."

would be unaware of what was happening until resistance to the final stages would be impossible and useless. But in 1958 Mr. Robert Welch, an experienced and well-connected business man, who for years had studied world history and more latterly the true history of Communism, took action. He arranged a meeting of American patriots, and over a two-day period outlined the situation as it existed at that time, and what he thought could and should be done about it.

As a result of that meeting the John Birch Society was founded, with Mr. Welch a Founder, and a Council of competent people to assist him. The objective of the Society is: "Less government, more responsibility, and a better world". Between that objective and the people everywhere stands the International Communist Conspiracy, so that the *immediate* task which the Society recognizes is the *defeat* of that Conspiracy. Its methods of carrying out this task are education, and co-ordinated and concentrated action on specific designated campaigns for tactical objectives.

We come now to the reason why the assertions of this article are not documented. Over many years, quite a large number of books, by people who have themselves been members of the Conspiracy but defected, or who have been in positions in the U.S. Government to have observed the actual treason with which it is infested, and books and articles by trained investigators and historians, have been published. Their authors in many cases have been murdered, or met with 'accidents', or been driven to suicide, which is evidence of the authenticity of the facts they have disclosed. Many of these books, on their appearance, have been suppressed as far as has been possible, and certainly have received no publicity through the mass communications media; and to the extent that they have reached the market, they have been in competition with the avalanche of pornography and socialist subversion which is one of the chief contemporary methods of brainwashing the public.

As one of its chief educational activities, the John Birch Society has either re-published or otherwise made available through its own "shipping room" adequate supplies of these books, and of other literature and documentation relating to the real existence of the Conspiracy, its nature, and intentions. And it is one of the chief purposes of the Society to get as many of these books out and in circulation and read by as many people as soon as it can be done.

And this is a vital task. All that now stands between us and the ultimate ghastly success of the Conspiracy is the existence of a sufficient number of informed, patriotic, American citizens. Effective resistance is no longer possible anywhere else in the world. Even the passage of the Civil Rights legislation might mark the point of no return, perhaps for centuries until the slow cycle of history and the vital spirit of man brought the decay of tyranny.

It is not too much to say—perhaps it is not enough—that the point of no return might already have been reached had it not been for the initiative of Mr. Robert Welch, and his utter dedication, and that of his followers, to the task they have set themselves. Some idea of the magnitude of that effort may be gained from the fact that this year they intend to turn over six million dollars, in the printing and dispatch of literature public presentations of films and recorded tapes, lectures, and general organisational expenses.

It is vital to realise that the plans of the Conspiracy do not include a conventional war by Russia. Russian armed forces are scheduled to appear on the scene, to prevent 'counter-revolution' after a strong central government has been im-

sed on the American people. It originally was intended that this be done so insidiously that it would be accomplished before the American people were aware of what had been done.

But the formation and growth of the John Birch Society, whose leadership, and increasingly its members, know exactly what they are up against, and what they have to do, and "which means business every step of the way", means the first conscious, educated, determined and organised resistance the Conspiracy has ever faced.

So there will be a showdown. The Conspiracy no longer has the unlimited time which would enable it to accomplish its purpose with that "patient gradualism" which heretofore has been the almost infallible guarantee of its success. Very probably, the murder of President Kennedy by agents of the Conspiracy, although bungled in its execution, is a sign of recognition by the Conspiracy that its time is limited. "The John Birch Society is an *educational* army, and our only weapon is truth". It is, for the first time in history, an army certain of victory unless overthrown soon, perhaps in the next two years, by force and terror.

What has to be done is by an ever-spreading knowledge of the truth, to strengthen the U.S. Congress so that through its investigating committees it can expose and rout out from their concealed positions of power within the Administration those members of the Conspiracy who at present are in effective control of the U.S. Government.

The John Birch Society estimates that it has reduced the chances against it from about one in a hundred when the Society was founded, to about one in four today. But as this ratio is further increased, they expect a snow-ball type of accretion to their ranks, and their task therefore is to build as rapidly as possible an adequate organisation to direct the army of truth against the correct objectives.

At this stage, *only* in America, and only by the methods to which the members of the John Birch Society are dedicated, can the Conspiracy be defeated. But defeat of the Conspiracy is but the immediate and vital task of the Society, because the Conspiracy stands between all people everywhere, and that "better world" which, as with Social Credit, is the ultimate aim. So that an ever-increasing spread of knowledge of the truth wherever it can be carried is the order of the day everywhere.

*The Social Crediter* has stood since its inception "for political and economic realism". The *economic* front of the Conspiracy today is invulnerable—although it is true that the accelerating productivity of the fully industrialised nations introduces a time-factor which limits the period in which "patient gradualism" could accomplish the purposes of the Conspiracy. The vulnerable front is the political. Douglas recognised this clearly, and from 1939 onwards emphasised with increasing urgency that the "international gangsters" had to be exposed and overcome before any progress towards a better world through *economic* realism could possibly be achieved.

Douglas also recognised that the problem of overcoming centralised power required centralised direction of resistance. In *The Tragedy of Human Effort*, written long before the second world war, he pointed out that in regard to the carrying out of any objective, centralisation of *administration* is essential: only the choice of *objectives* is a proper sphere for 'democracy'.

Visibly, the one objective of all who wish, not only to retain their freedom, but even, in a frightening number of cases, to save their lives, is to contribute in every way in their power to the overthrow of the Conspiracy. And just as visibly, the one body which knows what has to be done, and how to do it, but which needs every ounce of support it can get, financial and educational and moral, is the John Birch Society.

The Social Credit Secretariat will, through its distribution agencies, K.R.P. Publications and Tidal Publications, make available the educational material which is being used by the John Birch Society. We ask our readers to contribute as much money as they possibly can to enable us to finance the necessary stocks; to themselves buy, read, and get read by others, the books we recommend. *This* is the way, and the only way within sight, to defeat the Conspiracy which, if not defeated within the very foreseeable future, will certainly destroy any financial savings any of us have today. It is literally now a matter of "your money and your effort—or your life, as you know it, or in fact". Money power is required to overthrow Money Power, and at last a way has been found to do it.

There can be no slightest doubt that the John Birch Society is the spear-head of the attack on the Conspiracy. But their efforts will be enhanced by the support of as much educated opinion as can be mobilised throughout the world. And there is probably no other body of people than Social Crediters better able to mobilise that opinion. We are an international movement, while the John Birch Society, because of its necessary and dedicated concentration on the immediate objective, is not.

## Marxmanship in Dallas

[FOURTH INSTALMENT]

The functions of a “commission” so constituted are obvious. It will:

(1) Cover up for the Communist Conspiracy as much as possible by claiming that Comrade Oswald was a poor, lone critter who done it all alone. Probably “pyschiatrists” will be produced to prove he done it ‘cause, at the age of six months, he had to wait an extra five minutes for his bottle. That will establish the need for more Welfare and Civil Rights.

(2) Suppress permanently the report of the F.B.I., which it has already acted to conceal from the American people and, if permanent suppression proves impossible, to have the report watered down or at least kept secret until a “crisis” can be arranged that will make its publication pass almost unnoticed.

(3) Smother and suppress the evidence of close contacts between Oswald and Rubenstein in both Waco and Dallas during the period immediately preceding the assassination of Kennedy, and other evidence connecting both of them with mysteriously prosperous persons of unknown antecedents in the vicinity of New York City. Every effort will be made to conceal Rubenstein’s connections with Communist Cuba, including such items as a clandestine visit to Havana about a year ago, when he stayed with a long-time and close associate of Castro’s named Praskin, who operates, as a cover for his other activities, a “novelty store” on the Prado opposite the Seville Hotel.‡ It may even be possible to prevent the public from learning definitely whether or not the “Jack” Rubenstein who executed Oswald is the person of the same name who has a published record of Communist associations and activities in this country going back for many years.

(4) Harass the Dallas police as much as possible. This will convey to police forces everywhere an understanding of the inadvisability of interfering with Communists engaged in the discharge of their duties. I doubt that the “commission” will go farther than this, although I confess that I am disturbed by the persistence with which the “Liberal” columnists around the world, from France to Australia, insist that poor Oswald, an innocent little Communist, was “framed” by the “Fascist” police of Dallas.

(5) Try to smear and intimidate loyal Americans in every way possible. Much can be accomplished in this direction if the Congress can be pressured into voting un-Constitutional powers of subpoena to an un-Constitutional "commission" dominated by persons who should themselves be on trial for their efforts to subvert and destroy the Constitution. Since no American cow is wealthy after being milked by the Income-Tax collectors, and since the majority of conspicuously loyal Americans are persons of very modest means, just one item, the cost of employing attorneys, could give the gang the power to inhibit and even paralyse most of the opposition to treason in the crucial year of 1964. It is possible, of course, that the "commission" may simply assume such powers. If so, Congress will probably object; but, if it should be necessary, the august Chief Justice could dash over to the Supreme Court Building, put on his black robe, and rule that Congress, like God, is un-Constitutional. It's just a ten-minute trip by cab.

(6) To go as much further as may be feasible. It is reported in the Press that the "commission" has requested the power to "extort" testimony from "unwilling witnesses." At the time at which I write, it seems unlikely that any such un-Constitutional power will be un-Constitutionally granted. Of course, the original plan, to have been carried out *eventually*, if everything went according to schedule in Dallas, called for nice rubber-lined torture chambers (such as you may glimpse in that excellent film *My Latvia*, in which the hated Americans could be scientifically tortured into "confession," and the remains of those who proved "unco-operative" could be efficiently washed down the drains.

(7) To create propaganda for other Communist projects to facilitate the final conquest of the United States. A number are likely, but the most obvious one is the one that was contemplated when Comrade Oswald was careful to provide evidence that the rifle used in the assassination had been purchased by mail. It is eminently desirable that firearms now in possession of Americans can be confiscated, partly to convince the Conspiracy's serfs how helpless they are, and especially to reduce the occupational hazards to the Balubas, Outer Mongolians, or other beasts who may form the "international police force" that is to occupy the United States and butcher its white inhabitants.

(8) To co-operate when the Conspiracy arranges for further violence. We may be sure that such will occur at the earliest feasible moment, and that every precaution will be taken to avoid a slip-up such as occurred in Dallas. It is impossible to predict at this moment when such an incident will occur or what form it will take—except, of course, that the blame will fall on "right-wing extremists." The assassination of other high government officials is an obvious possibility—perhaps too obvious, despite the sudden yapping of "Liberals" that something must be done quick to prevent the succession of John McCormack, as now provided by law. (*Newsweek*, THE WEEKLY LIEPAPER published by the *Washington Post*, had the effrontery to state the cause for alarm: McCormack is suspected of "anti-Communism"! ) The Conspiracy, however, might go so far as to arrange the assassination of some Justice: That could, perhaps, be made to seem plausible after the Warren Court has maltreated a number of Americans in its latest usurpation of un-Constitutional powers, and it is, furthermore, the only *sure* way of preventing an impeachment and trial by Congress.

But another assassination would seem a bit monotonous, unless preceded by several other incidents of a different pattern. A hundred varieties of incidents are possible, such as first-class race riots, an "accidental" nuclear explosion to pep up agitation for "disarmament," or a well planned series of *almost* convincing "suicides" of American "rightists." A properly timed "crisis" in Latin America, preferably near to our borders, would be a suitable intermezzo during the performance. We cannot now predict precisely what arrangements the unknown Directorate of the Conspiracy will deem most expedient, for it is likely that their choice of both time and events will be made after they have seen how much advantage they will have been able to extract from the Kennedy assassination.

One thing is certain, however: The bungle in Dallas, far from justifying the slightest relaxation, should summon us to the utmost vigilance. It should warn us that we have come to the year of decision, and that only our devoted and united efforts can prevail against a gang of international murderers rendered desperate by the awareness that their time is running out.
